

2.1	Matters Arising	
2.1.1	Southwark Park – Former Social Club 386 Southwark Park Road	
	On the issue of encroachment on park land Andrea reported a site visit had taken	
2	place and it was concluded there was no infringement by the developers.	
3.	Southwark Park Sports Centre Update Come Clayer reported on the macting with Poten John Loader of the Council on	
	Gary Glover reported on the meeting with Peter John, Leader of the Council, on Monday 25 th November, which was positive. Since that meeting the Council had	
	allocated £1.7m towards the scheme. It was agreed we invite Tim Clee to a future	
	meeting to provide more detail and that we also confirm FOSP wishes to be	
	represented on the project team that implements the scheme. It was also agreed to	
	ask for more consultation over the idea of bringing the land on Hawkstone Road	Pat

	N.B. Due to prior commitments Tim is unable to attend our February meeting	
	but has provided this update via email:	
	Pro rada tino apanto (in tinan)	
	'Phase 1 (Athletics Facilities) - all funding is secured (London Marathon, Mayor	
	of London, Sport England, s106. Southwark Olympic Legacy) and we are	
	currently at pre-planning stage. Subject to feedback from planning we anticipate	
	submitting a planning application in mid Feb. If timescales work out we will start	
	the work early summer 2014 with a completion date of Spring 2015. The works	
	include reinstating the athletics track, and turning the astropitch into a grass pitch	
	to enable us to deliver a full programme of athletics track and field activities.	
	Phase 2 (Building refurbishment) - we are waiting for official confirmation of	
	funding from the councils internal capital pot, although there has been an	
	announcement by politicians that funding will be made available. But we won't	
	know exactly until February. If all goes well this phase of the project should be	
	delivered at roughly the same time as Phase 1. The building refurbishment should	
	include changing provision for the parks pitches, and also toilets that can be used	
	by park users, and well as facilities that will support the development of	
	athletics. This will be subject to final designs which will be progressed as soon as	
	we have confirmation of the funding.'	
4.	Old Nursery Master Plan Update	
	Max Nakrani reported that following previous consultation the Harrison Design's	
	sketch options for the site have been reduced from five to three as FOSP had	
	requested. In addition Parks senior management have called for other options to be	
	considered, including a potential formal garden on the old nursery land; a Canada	
	Water Green Link with a new entrance to the park from Lower Road; and a

	relocation of the café and offices to the Art Gallery building with a new Gallery on the present office/café site.

	There was a full discussion and many points raised. In summary:	
	Concerns about the delay and lack of clarity over the Master Plan	
	consultation – the final report was originally due in December 2013	
	 Surprise and concern that the gallery/café and office 'swap' has been 	
	introduced at such a late stage without any notice of such a major change	
	in the Master Plan brief with FOSP	
	 Concerns that the straightforward priorities of a better café, offices and 	
	sympathetic public use of the old nursery land could be delayed or even	
	lost in the unnecessary complications of gallery and Green Link options	
	Questions about the financial and service implications of the Gallery	
	'swap' – who will pay for a new gallery and will the café have to close	
	while it is being built?

	Pat reported that the Heritage Lottery Fund had declined to award a grant for the	
	150 th activities. However, it is still possible to do something and he circulated a	
	draft Programme of Events which, subject to various grant applications, will be	
	finalised by April.	
	On Neil Coyle's suggestion it was agreed to approach North Southwark	Pat
	Environment Trust and Bee Urban for funding.	Kingwell
6.	Cleaner, Greener Safer Programme Update	
	Pat reported that a bid for £38,000 had been submitted to improve Southwark Park Playground by repairing the water feature; providing a bee demonstration hive;	
	two outdoor table tennis tables and a fenced off dog-free area, and Amanda had	
	previously reported she was submitting a bid to cover the £11,000 shortfall on the	
	Fulford/Cathay Street scheme originally approved in 2009 for £30,000. Awaiting	
	decision from Community Council on 29 th January.
