## Appendix 2 Firework Display

With my health and safety advisor we have had a thorough review of the site and production schedules and looked at some of the issues brought up from last years. We have created a plan that has retained access to the majority of the activity that takes place in the south end of the park but has had to restrict some access too. With lots of infrastructure and pyrotechnics being brought into and being moved around the park I have to keep the safety of both park users and my team at the forefront of my mind. I believe that this new plan minimises disruption for a really great event that remains free for residents. Here are the details.

Generally the south end of the park will be closed to all park users from Friday 3rd November at 8am till Tuesday 7th November at 12pm.

Access will remain open for those using:

Children's playground

- CGP London (Café Gallery)
- One O'clock Club building (Rotherhithe Primary School)
- Running track
- Cafe

Some specifics:

There will be no access for pedestrians or vehicles via China Hall Gate and Dilston Grove Gate. Hawkstone Road car park will remain be open except for Sunday 5th November. Access for pedestrians will be limited to a cordoned area between the car park and the One O'clock Club building. This can be used by dog walkers but there will be no access to the rest of the park. There will be no general parking on Gomm Road carriageway with access only given to Blue Badge holders.

- There will no access to the running track from Saturday 4 November at 12pm till Monday 6 November at 2pm.
- There will be no access for the general public to Dilston Grove.

We have been working with some of the organisations impacted already and will have spoken to all of them by the end of the week. To ensure that park users know what is happening we will be placing advance warning notices around the park two weeks before pointing people to us if they have any questions.

## Background

## **Proposed Schemes**

## Southwark Park Interpretation Boards

## New Bandstand Event Folding Chairs

The chairs available for bandstand and other events has significantly reduced since their original purchase about fifteen years ago. We now have less than 30. As there are only a few park benches near the bandstand spectators are often forced to sit on the grass or stand. It is proposed to purchase 125 new plastic, folding chairs.

#### 1. Introductions

Councillor Hargrove welcomed everyone to the meeting and introductions were made amongst the attendees. Hemali provided an overiew of the agenda for the evening.

Kelly stated she was interested to hear about the plans for the park as Rotherhithe Primary School are building an outdoor nature classroom for the children and did not want any duplications with the park.

#### 2. Update on Southwark Park projects

Southwark Park Masterplan Hemali explained that the project for the new café and office building is currently in the pre construction phase with the contractors. The contractors and the architects are working to finalise the finer details of the scheme and we will be in a position to commence the works on site in the New Year.

The nursery works will commence upon completion of the new café building to ensure there is no downtime for the park office or the café. Once the building is completed there will be a period of approximately 1 month where the move of the café and office can take place, following this demolition can commence. These works are likely to start in Winter 2018.

Southwark Athletics Centre The athletics track is proving popular and is regularly used during the week by the athletics club.

An update regarding the athletics centre was sent to all stakeholders earlier in the year. The foundations and the structural integrity of the current building would require a lot of work before any refurbishment could take place, as such the council reviewed the options presented by the consultants and reached a decision to demolish the existing centre and build a new athletics centre in the same location.

Hemali confirmed that the centre will not be larger than it currently it is and it will accommodate many of the same facilities. A new planning application will be submitted for this in Spring 2018 with a view to works starting on site in Autumn 2018.

Kelly queried how schools can get involved with using the track, Hemali is to query this with the sports team and provide a response. Action Hemali

3. Top Quality Play design

All attendees were provided with handouts of the consultation plans for Southwark Park Playground which included an overview of the current playground, a design of the new scheme with a key and a mood board featuring samples of the materials and play equipment.

A discussion took place around the design and all attendees where pleased with the new scheme and what it had to offer. They particularly liked the new steps up to the slide and thought this would encourage climbing amongst the children.

Hemali explained the woodland area would be thinned out and features such as logs will be installed to encourage natural play.

Hemali confirmed that all internal railings will be removed but the boundary railings are to be retained. The hedging will be reduced in height and thinned out to increase visibility into the playground.

Hemali confirmed that all surfacing surrounding the play equipment would be safety surfacing.

A request was made that graphics were painted onto the paths to encourage play e.g. hopscotch. Noted

An issue was raised regarding drainage of the current water feature and to ensure that a larger water feature had the capacity for drainage. With the current splash pad the water runs into the hedges and causes ponding in areas. Noted

All attendees were encouraged to complete the survey and feedback any other thoughts they may have regarding the scheme.

Hemali stated that the old lido fountain does not fit within this scheme as the budget for the playground cannot cover refurbishment of the fountain. However, the parks team recognises that work is required to the fountain and has made a request to FOSP to submit a CGS application for this.

Hemali will be attending the start of the Friends of Southwark Park meeting to provide an update on the projects in Southwark Park and discuss the playground plans.

5. Next steps

The consultation results will be reviewed in November and the scheme will be finalised by the Landscape Architects during this time. We are aiming to start works on site in the New Year with a view to completing the scheme in March 2018.
