The Friends of Southwark Park Annual Report 2015/16 – Draft for Discussion and Approval

Our aims and objectives are the promotion, protection and enhancement of Southwark Park, King's Stairs Gardens, King George's Field and West Lane Memorial Gardens, to be achieved in partnership with other organisations and the wider community. Here is a list of some of our main achievements, month-by-month, over the past year.

September 2015

- Successfully called for repairs to the outdoor gym and the provision of a handrail in the Ada Salter Garden
- Received a grant from Amicable Trust to support beekeeping activities
- Hosted young volunteers from the National Citizenship Programme Network Challenge
- Achieved the renewal of lettering on the West Lane War Memorial
- Secured confirmation from Southwark Council that King George's Field would not be opened 24 hours a day

October 2015

- Saw two new tennis courts opened by Cllr. Barrie Hargrove and Greg Rusedski following our Cleaner, Greener, Safer Fund award
- Relocated the Brownies' mural from Scout House to the cafe
- Commented on the planning application for flats at The Lodge, Lower Road

November 2015

- Attended the Remembrance Day event at West Lane Memorial Gardens and laid a wreath
- Completed the bandstand refurbishment works following our Cleaner, Greener, Safer Fund award
- Raised concerns about the pulling down of the boundary wall of the former Swedish Church

December 2015

- Ran a promotional stall in Surrey Quays Shopping Centre
- Held a public consultation event about the proposed new Café

	Project Description	Current Position
1	Southwark Park south-western boundary improvements In October 2014 we agreed that boundary improvements were needed. We asked if the Maydew House redevelopment scheme might help provide a solution.	The Maydew Project Team will attend our September meeting to advise on progress.
2	Southwark Park Sports Centre A major refurbishment scheme including reconstruction and layout changes of synthetic athletics track, conversion of synthetic turf football/hockey pitch to natural grass, installation of a hammer and discuss cage and the relocation and installation of the following athletic facilities: shot putt circle pole vault runway long/triple jump runway and pit high jump fan and javelin runway. Additional works include landscaping to facilitate these changes and the movement north of the fence at the southern boundary. As a second phase the changing rooms will be improved, including remodelling of the internal areas of the building.	 Blakedown Group contractors were appointed to implement the scheme and Faithful and Gould are Project Managers. Track surfacing and landscaping works are now complete. On pooling of water contractors and consultants have confirmed that this is because the surface is non-porous. The surface has been laid at a slight gradient which meets the specification, however pooling has a tendency to occur on tracks of this type and in most circumstances is swept off. The infield has been seeded and will be available to use from Summer 2017. For the second phase building refurbishment the planning application has been submitted and consent will be determined at a planning sub-committee. Following approval we will

Kinnear Landscape Architects have developed a plan for the site. The retention of the existing café building remains an issue to be resolved before plans are finalised.
